



POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, THAT;

1. to prepare and file with Director of Kanto Local Finance Bureau the Report on Large Shareholding and any amendments, supplements or changes thereto relating to CGML's shareholding in companies listed on any of the stock exchanges in Japan pursuant to Chapter 2-3 of the Financial Instruments and Exchange Law of Japan;
2. to send copies of the said report to the issuing companies; and
3. to do such other things as are necessary in connection therewith.

The CGML hereby confirms and ratifies all that the said Attorneys shall do or cause to be done in pursuance of the purpose herein contained.

This Power of Attorney is governed by English law and shall remain in full force and effect in favour of such Attorney up to and including the earlier of (a) 30th June 2026; (b) the date when CGML gives notice that this Power of Attorney has been revoked; (c) the stated purpose of this Power of Attorney has been accomplished; (d) the relevant Attorney ceases to be employed by CGML or its affiliate; or (e) the relevant attorney no longer performs the function or responsibilities stated above.

委 任 状

本書面を以て以下を知らせるものとする。

本委任状は、西暦 2025 年 6 月 18 日に、英国ロンドン市 E14 5LB、カナリーワーフ、カナダスクエア、シティグループセンターに主要な営業所を有するシティグループ・グローバル・マーケッツ・リミテッド（以下、CGML という）により作成された。

CGML は、本書面により、東京都千代田区大手町一丁目 1 番 1 号に登記上の本店を有するシティグループ証券株式会社の代表取締役社長兼 CEO ロバート・ナカムラを真正かつ適法な代理人として定め、以下に掲げる事項のうち、代理人が CGML のために適切と認めるものを、CGML の名でその代理として遂行する権限を委任する。

本委任状は英国法に準拠し、西暦 2026 年 6 月 30 日まで効力を有す。ただし、本委任状が取り消されたとき、本委任状で委任された事項の目的完了、及び、本委任状に基づき権限を委任された代理人が CGML 又はその関係会社の使用人でなくなった場合、のうちのいずれかの事由が発生したときに直ちにその効力を失うものとする。
